- 2) It was decided that Justice Abhijeet Sinha shall be the local editor for the SXAA Newsletter. A request through e-mail shall be sent to Kolkata, Delhi, Mumbai and Ranchi chapters of SXAA to submit an article on their activities for the newsletter.
 - 3) Dr Amulya K Singh expressed his willingness to sponsor the upcoming issue of SXAA Newsletter which was heartily welcomed by the EC members.
