The following decisions were taken unanimously by the Executive Committee:

- 1) It was decided that the theme for the JAAI National Congress to be hosted by SXAA, Patna on 4<sup>th</sup>, 5<sup>th</sup> & 6<sup>th</sup> February 2011 shall be '**Public – Private Partnership for better Education**'. This decision along with all the details as decided in the last meeting held on 01<sup>st</sup> May 2009 was communicated to Fr Chandy, SJ, Province Coordinator, Patna Province with a request to inform the same to all concerned in JAAI.

- 2) It was decided to request Mr Arun Prasad to prepare a list of hotels of various categories as well as other free single accommodation available in Patna for accommodating the outstation guests/participants during the JAAI Milan '2011. He may also be requested to consult some Tour & Travel agencies for providing packaged tour for near about tourist places to the outstation guests/participants and sponsoring/preparing brochure for the event.
- 3) It was decided that Mr N K Singh and Dr Shashi Tharoor shall be invited and requested to be the 'Guest Speakers' during JAAI Milan'2011.
- 4) Mr Anshul Sinha stated the current financial position of the SXAA which are as follows:
  - a) Rupees 2 Lakhs (approx.) – Post Office.
  - b) Rupees 5.5 Lakhs - FD ( IDBI) – already renewed
  - c) Rupees 3.5 Lakhs (approx.) – SBI Saving Bank A/c which includes the matured amount of approx Rs 80,000 from UTI bonds and Rs 1,00,000 donated by 1958 batch and Rs 50,001 donated by 1993 batch.
  - d) Further, there are no major liabilities present as of now.
- 6) It was further decided that Mr Vikramaditya Sinha be requested to prepare a Balance Sheet for the last financial year.
- 7) It was decided that Rupees 300.00 (only Rs Three Hundred only) per month shall be given for sweeping with material at least twice a week and specially before the executive committee meet.
- 8) The next meeting of executive committee shall be held on 08<sup>th</sup> August 2009
