The following decisions were taken unanimously by the Executive Committee:

- 1) Mr. J. K. Sinha, President informed that the DIG (Registration) has approved the registration of SXAA under Society Act, 1861 and the registration certificate for the same will be issued very shortly.
- 2) It was decided that a press conference shall be arranged at the St. Xavier's Patna, a week before the Annual Reunion 2008 i.e. on 11th December 2008 (Thursday).
- 3) It was decided that the Guests of Honour at the Annual Reunion, 2008, will be the Distinguished Xaverian Awardees only.
- 4) Dr Amulya Kumar Singh, Secretary informed that the catering, music & entertainment, and all venue arrangements for the Annual Reunion 2008 have been booked. Mr. Ravi Saluja , M/s Milan Decorators, Nala Road who has been entrusted with the decoration & lighting arrangements was also present in the meeting
- 5) All present at the meeting were requested to make all out efforts to raise funds for the souvenir.
- 6) It was decided that an article each should be sought from 1958 batch and 1983 batch for the souvenir to be published on the occasion of the Annual Day.

- 7) As suggested by Mr. Ravi Nandan Sahay, it was decided to create 1958 Batch Foundation to be funded by the 1958 batch and managed by SXAA. It was further decided that trophy / trophies be instituted in the memory of those alumni of 1958 batch who have passed away and it should be given to the winning house for a competitive event to be decided by 1958 batch in consultation with the school principal and the recitation at the time of presenting the trophy should include the names of alumni in whose memory the trophy is instituted. Fr. George Nedumattam, S.J., Principal was requested to provide a list of competitive activities of the school so that 1958 batch could choose the event for which they would like to institute the trophy. Furthermore, it was decided that a minimum of Rs. One Lakh in FD should be created by a batch for instituting a trophy in its name.
- 8) It was decided that the Mr. Rajkumar, who is working as office assistant at St. Xavier's, Patna, shall look after the office work and other miscellaneous work of the SXAA office. A fixed sum of Rs. 700 shall be paid to him from this month (October, 2008) for this part time work.
- 9) It was decided that the SXAA office decoration work which includes curtains, rods & glass films be awarded to M/s Inside Décor, Fraser Road, Patna and a work order to this effect shall be issued to get the work done at the earliest.
- 10) It was decided that the next meeting of the SXAA executive shall be held at SXAA office, St. Xavier's High School, Patna on 29th October 2008 at 5:00 PM.
